## **Administrative Update**

- Journey Night was a great success! P/T conferences coming up this week, October is fire prevention month, planning for harvest feast to begin, family education night in the works for November

- School directory will now go through Brightwheel
- Enrollment: Two new elementary students will start December 1. Another inquiry incoming about a 7-year-old interested. Discussed concerns about the overabundance of 3 year olds and how that will effect classroom balance moving forward—waiting list policies are now set up to avoid such a scenario in the future.

- Management agreement: expired end of August, negotiations between lawyers, PSP decided to not renew after
  this school year; looking into continuing the conversation and requesting to be on the PSP school board agenda
